PRIVACY POLICY & CALIFORNIA CONSUMER PROTECTION ACT | FRANKLIN GOLD

Thank you for accessing the Franklin Gold website operated by Franklin Gold, We respect your privacy and want to protect your personal information. The Privacy Act of 1974, 5 U.S.C. § 552a, establishes a code of fair information practices that governs the collection, maintenance, use, and dissemination of information about individuals that is maintained in systems of records by federal agencies. A system of records is a group of records under the control of an agency from which information is retrieved by the name of the individual or by some identifier assigned to the individual.

The Privacy Act requires that agencies give the public notice of their systems of records by publication in the Federal Register. The Privacy Act prohibits the disclosure of a record about an individual from a system of records absent the written consent of the individual, unless the disclosure is pursuant to one of twelve statutory exceptions. The Act also provides individuals with a means by which to seek access to and amendment of their records, and sets forth various agency record-keeping requirements. INFORMATION COLLECTION AND USE

1: We collect information from you several different ways on this website. One goal in collecting personal information from you is to provide an efficient, meaningful, and customized experience. For example, we can use your personal information

To:

- A. Help us create content that is most relevant to you; and
- B. Alert you to new information, products, and services that we offer.
- C. Registration and Ordering. Before subscribing to certain features, you must complete an online registration form. During registration, you will be prompted to provide to us certain personal information including, but not limited to, your name, address, telephone number, and email address. If you choose to purchase a product online, we will ask for your name, telephone number, billing address and credit card number and related information. These kinds of personal information are used for billing purposes, to fulfill your orders, to communicate with you about your order and the Sites, and for internal marketing purposes. If we encounter a problem when processing your order, your personal information may be used to contact you. We may also use your personal information to verify the delivery or credit card information or otherwise conduct due diligence to ensure proper processing of your order and to minimize the risk of fraudulent transactions. In conducting due diligence, we may acquire additional personal information from third-parties such as Accurint. We also may verify your personal information including addresses and telephone numbers using third-party providers.
- D. Forms and Applications. Several forms such as our Account Agreement may be completed and submitted online. These forms generally ask for personal information such as your name, address, telephone number, and email address. Depending on the form or application, this information is used to set up an account, complete an order, contact you about your order, and provide email news alerts and other email marketing and for internal marketing purposes. You may also download forms from the website, which are then transmitted to Franklin Gold, These forms ask for personal information, which may include your name, address, telephone number, driver's license number, email address, Social Security Number, and date of birth.
- E. Email Addresses. Several locations of the website permit you to enter your email address for purposes including but not limited to: registering for information or to access certain information, sign up for email news alerts and special offers, or to order a product online.
- F. Log Files. As is true of most websites, this website server automatically recognizes the Internet URL from which you access the website. We may also log your Internet protocol ("IP") address, Internet service provider, and date/time stamp for system administration, order verification, internal marketing, and system troubleshooting purposes. An IP address may indicate the location of your computer on the Internet.
- G. Franklin Gold, does not respond to web browser "do not track" signals or other mechanisms that provide consumers the ability to exercise choice regarding the collection of personally identifiable information about an individual consumer's online activities over time and across third-party websites or online service collection.
- H. Our Company Commitment to Children's Privacy. Protecting children's privacy is especially important to us. It is our policy to comply with the Children's Online Privacy Protection Act of 1998 and all other applicable laws. We therefore do not knowingly or intentionally collect personal information

from persons who are under eighteen years of age. If you are under the age of eighteen, you are not permitted to access this website and/or to submit any personal information via this website. Due to the age restrictions for use of this website as stated herein, no information obtained by this website falls within the purview of the Children's Online Privacy Protection Act, and information submitted to this site is not monitored for such purposes.

- I. Social Security Numbers. We collect Social Security numbers when it is required to perform a service such as purchasing certain precious metals from a customer, providing goods related to a self-directed IRA, or as required by applicable law.
- 2: Cookies and Other Technology. Like many sites, this website employs cookies and web beacons (also known as clear GIF technology or "action tags") to speed your navigation of the website, recognize you and your access privileges, and track your website usage.
- A. Cookies are small pieces of information that are stored as text files by your Internet browser on your computer's hard drive. Most Internet browsers are initially set to accept cookies. You can set your browser to refuse cookies from web sites or to remove cookies from your hard drive, but if you do, you will not be able to access or use portions of this website.

We have to use cookies to enable you to select products, place them in an online shopping cart, and to purchase those products. If you do this, we keep a record of your browsing activity and purchase. THE SITE'S COOKIES DO NOT AND CANNOT INFILTRATE A USER'S HARD DRIVE TO GATHER A USER'S CONFIDENTIAL INFORMATION. Our cookies are not "spyware."

- B. Web beacons assist in delivering cookies and help us determine whether a web page on this website has been viewed and, if so, how many times. For example, any electronic image on this website, such as an ad banner, can function as a web beacon.
- C. Where cookie technology is unavailable we may use an anonymous identifier to speed your navigation of the website, recognize you and your access privileges, and track your website usage. An anonymous identifier is a random string of characters that is used for the same purposes as a cookie on platforms, including certain mobile devices where cookie technology is not available.
- D. We may use third-party advertising companies to help tailor our website content to users or to serve ads on our behalf. These companies may employ cookies and web beacons to measure advertising effectiveness (such as which web pages are visited or what products are purchased and in what amount). Any information that these third-parties collect via cookies and web beacons is not linked to any personal information collected by us. As an example, Facebook collects certain information via cookies and web beacons to determine which web pages are visited or what products are purchased. Please note that any information collected by Facebook via cookies and web beacons is not linked to any customer's personal information collected by us.
- 3: Information Use and Disclosure.
- A. Internal Use. We use your personal information to process your order, provide requested information, and provide you with customer service. We may internally use your personal information to improve this website's content and layout, to improve outreach and for our own marketing efforts

(including marketing our services and products to you), and to determine general marketplace information about visitors to the website.

- B. Communications. We will use your personal information to communicate with you about this website and your orders as well as requests for information and deliveries. Also, we may send you a confirmation email when you register or order with us. We may send you a service-related announcement on the rare occasions when it is necessary (for example, if we must temporarily suspend our service for maintenance). You may submit your email address for reasons such as to sign up for email news alerts and special offers, or to request free information about acquiring precious metals. If you submit your email address, we use it to deliver the information to you. We always permit you to unsubscribe or opt out of future emails (see the opt out section below for more details). Because we have to communicate with you about orders that you choose to place, you cannot opt out of receiving emails related to your orders.
- C. External Use. We want to provide you with excellent service. We do not sell, rent, trade, license or otherwise disclose your specific personal information or financial information to anyone other than to affiliates under our control. However, the following exceptions may apply:
- i.) As do many retailers, we sometimes use third parties to perform specific functions on our behalf. When we disclose information to these service providers, we disclose information to help them to perform their service. For example, in order to deliver products to you, we must share some information. We work with third-parties (such as the U.S. Postal Service, UPS®, and FedEx®) to ship products, ensure delivery, obtain feedback, improve the quality of our service, and measure and improve the quality of the third-party's service. In the example of shippers, we provide them with some personally identifiable information such as your name, shipping address, email, and phone number. We also disclose personally identifiable information to third-parties who perform marketing or marketing research on our behalf. We generally require entities with which we share your nonpublic personal information, including companies that process or service transactions for us, to agree to keep your information confidential. We also prohibit them from using or disclosing your information except for the limited purpose and to the persons for whom disclosure was intended, or as otherwise permitted by law.
- ii.) Similarly, to help you buy products and provide customer service to you, we must provide your credit card number to financial services corporations such as credit card processors.
- iii.) We may disclose personal information in response to requests from law enforcement officials conducting investigations, subpoenas, a court order, or if we are otherwise required to disclose such information by law. We also will release personal information where disclosure is necessary to protect our legal rights, enforce our Terms of Use or other agreements, or to protect others or ourselves. For example, we may share information to reduce the risk of fraud or if someone uses or attempts to use this website for illegal reasons or to commit fraud.
- iv.) We will not sell, trade, or rent personally identifiable information to other companies as part of our regular course of business. However, it's possible that we might acquire, merge with, be acquired by another company, or that we might dispose of some or all of our assets. If that happens, your personal information may be disclosed to another company, but that disclosure will be subject to the Privacy Policy in effect.
- v.) We may share non-personal information (such as the number of daily visitors to a particular web page, or the size of an order placed on a certain date) with third-parties such as advertising partners.

This information does not directly personally identify you or any user.

vi.) We may update and supplement personally identifiable information that we have collected directly from our customers with other information that we obtain from third-parties. This may include information regarding demographics, income estimations, households and marital status. In addition, we may obtain personally identifiable information about individuals who are not yet users of our website or customers of Franklin Gold, When we associate information that we obtain from third-parties with personally identifiable information that we have collected under this Privacy Policy, we will treat the acquired information like information that we collected ourselves. Except as permitted by this Privacy Policy, the information will not be shared with third-parties. We purchase marketing data from third-parties and add it to our existing user database to better target our advertising and to provide pertinent offers in which we think you would be interested.

To enrich our profiles of individual customers, we tie this information to the personally identifiable information they have provided to us.

vii.) Finally, we may take your personally identifiable information and make it non-personally identifiable, either by combining it with information about other individuals (aggregating your information with information about other individuals), or by removing characteristics (such as your name) that make the information personally identifiable to you (de-personalizing your information).

Given the nature of this information, there are no restrictions under this Privacy Policy upon the right of Franklin Gold, to aggregate or de-personalize your personal information, and Franklin Gold, may use and/or share with third-parties the resulting non-personally identifiable information in any way.

DATA SECURITY

The security and confidentiality of your information is important to us. We have implemented certain technical, administrative, and physical security measures designed to help protect customer information from unauthorized access and improper use. This is an ongoing process and, from time to time, we review our security procedures in order to consider appropriate new technology and methods. Please be aware that despite a company's best efforts, no security measures are perfect or impenetrable.

This website incorporates physical, electronic, and administrative procedures to safeguard the confidentiality of your personal information, including Secure Sockets Layer (SSL) for all financial transactions through the website. We use SSL encryption to protect your personal information online. We also take several steps to protect your personal information in our facilities. Personal information may be printed or otherwise stored in a non-electronic form. Employees who need access to your personal information to perform a specific job are permitted access to your personal information. Finally, we may rely on third-party service providers for the physical security of some of our computer hardware. We believe their security procedures are satisfactory. For example, when you visit this website, you access servers that are kept in a secure physical environment as well as behind a locked cage and an electronic firewall. Franklin Gold does not guarantee complete security either online or offline.

DISCLOSURE OF INFORMATION

YOURE CALIFORNIA PRIVACY RIGHTS

The California Consumer Privacy Act (CCPA), enacted in 2018, creates new consumer rights relating to the access to, deletion of, and sharing of personal information that is collected by businesses. CCPA provides the right to request the following information from a business:

- Categories and specific pieces of personal information collected in the preceding twelve months;
- 6.) Categories of sources from which the personal information was collected in the preceding twelve months;
- 7.) The business purpose for collecting or selling such information;
- 8.) Categories of third parties with whom the business shares personal
- information; and
- 9.) Deletion of personal information about a consumer that the business has

collected

You may obtain personal information any time, but Franklin Gold, is not required to provide such information to a customer more than twice in a twelve-month period. Upon a verifiable request, Franklin Gold, will provide the customer with their personal information within 45 days at no cost. This information will be provided electronically or by mail. Note that Franklin Gold, is prohibited from discriminating against any customer for exercising their consumer's rights.

You can exercise your rights as a data subject in California and the entire United States via our contact forms. Upon receipt of a verifiable request to delete a customer's personal information, Franklin Gold,

will delete the information and direct any service providers to delete the information from their records unless the business or service provider needs the information to:

- 10.) Complete the transaction for which the personal information was collected, provide a good or service requested by the consumer, or reasonably anticipated within the context of a business's ongoing business relationship with the consumer, or otherwise perform a contract between the business and the consumer;
- 11.) Detect security incidents; protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;
- 12.) De-bug to identify and repair errors within existing intended functionality;
- 13.) Exercise free speech, ensure the right of another consumer to exercise his/her right of free speech, or exercise another right provided for by law;
- 14.) Comply with the California Electronic Communications Privacy Act;
- 15.) Engage in public or peer-received scientific, historical, or statistical

research in the public interest;

- 16.) To enable solely internal uses that are reasonably aligned with the expectations of the consumer based on the consumer's relationship with the business;
- 17.) Comply with a legal obligation; or
- 18.) Otherwise use the consumer's personal information, internally, in a lawful manner that is compatible with the context in which the consumer provided the information
